HS CODE: 08011910

# SEMI-HUSKED COCONUT

HS CODE : 08011910

Semi-husked coconut is a coconut that has been harvested and only the top has been peeled slightly to reveal the cap. It still contains coconut fiber and coconut water. Semi-husked coconut is used for various purposes, such as food processing, beverages, cosmetics and fuel







# HUSKED COCONUT

HS CODE: 0801

A husked coconut is a coconut that has had its outer husk or shell removed, leaving the inner fruit exposed. The husk is the tough, fibrous outer layer of the coconut, and it is usually brown, depending on the maturity of the coconut. Once the husk is removed, the remaining part of the coconut, which is the seed or fruit (the meat), can be used for various purposes.







# COPRA

HS CODE : 12030000

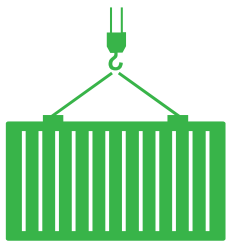
Copra is the dried meat or kernel of a mature coconut, typically the one that has fallen to the ground. It is obtained by removing the coconut's husk and breaking open the hard shell to extract the white flesh inside. This flesh is then sun-dried, smoke-dried, or dried using other methods until it becomes dry and crisp. Copra has a lower moisture content compared to fresh coconut flesh.
